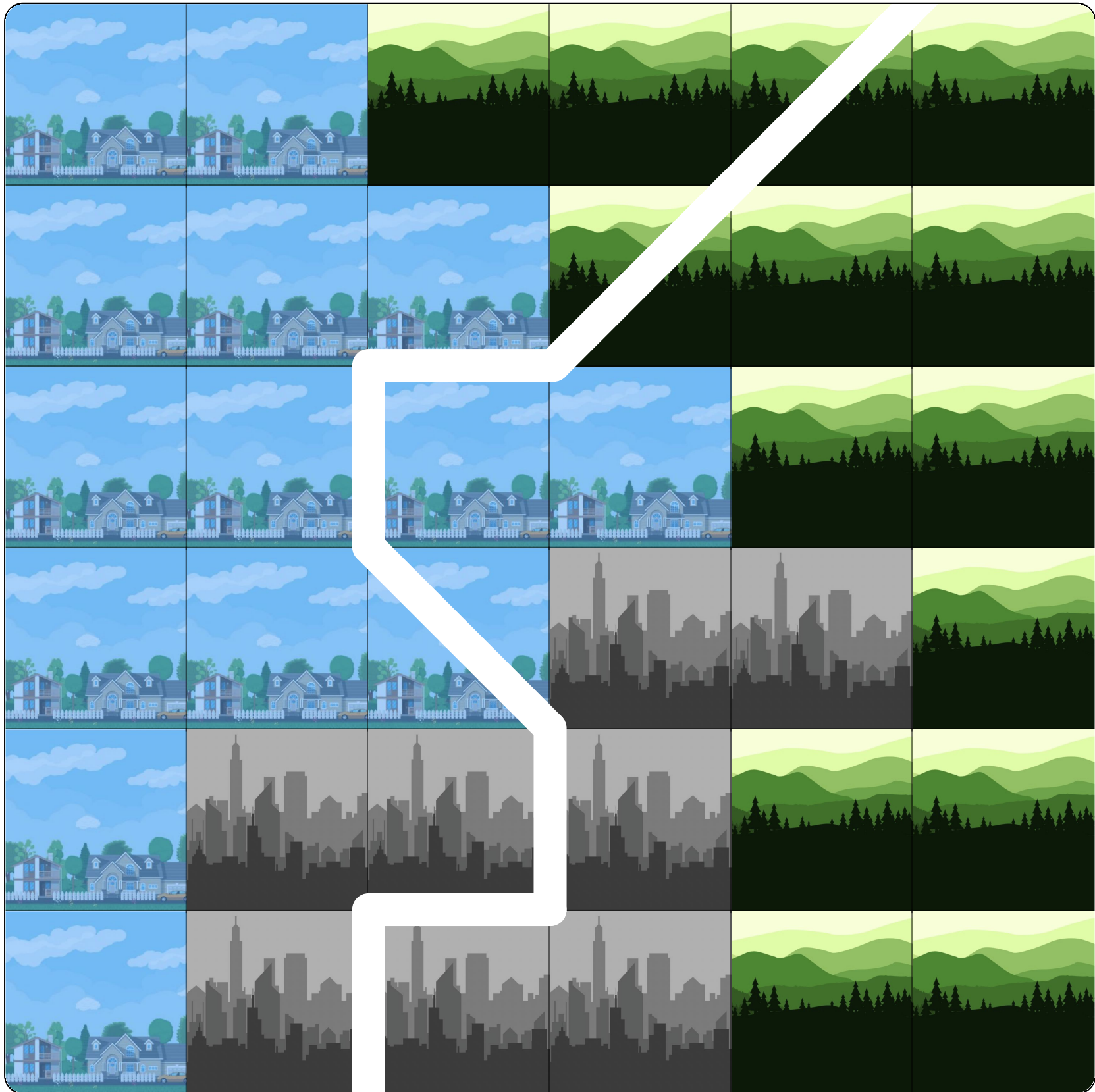

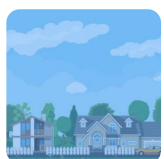
Open Space: Columbia Park

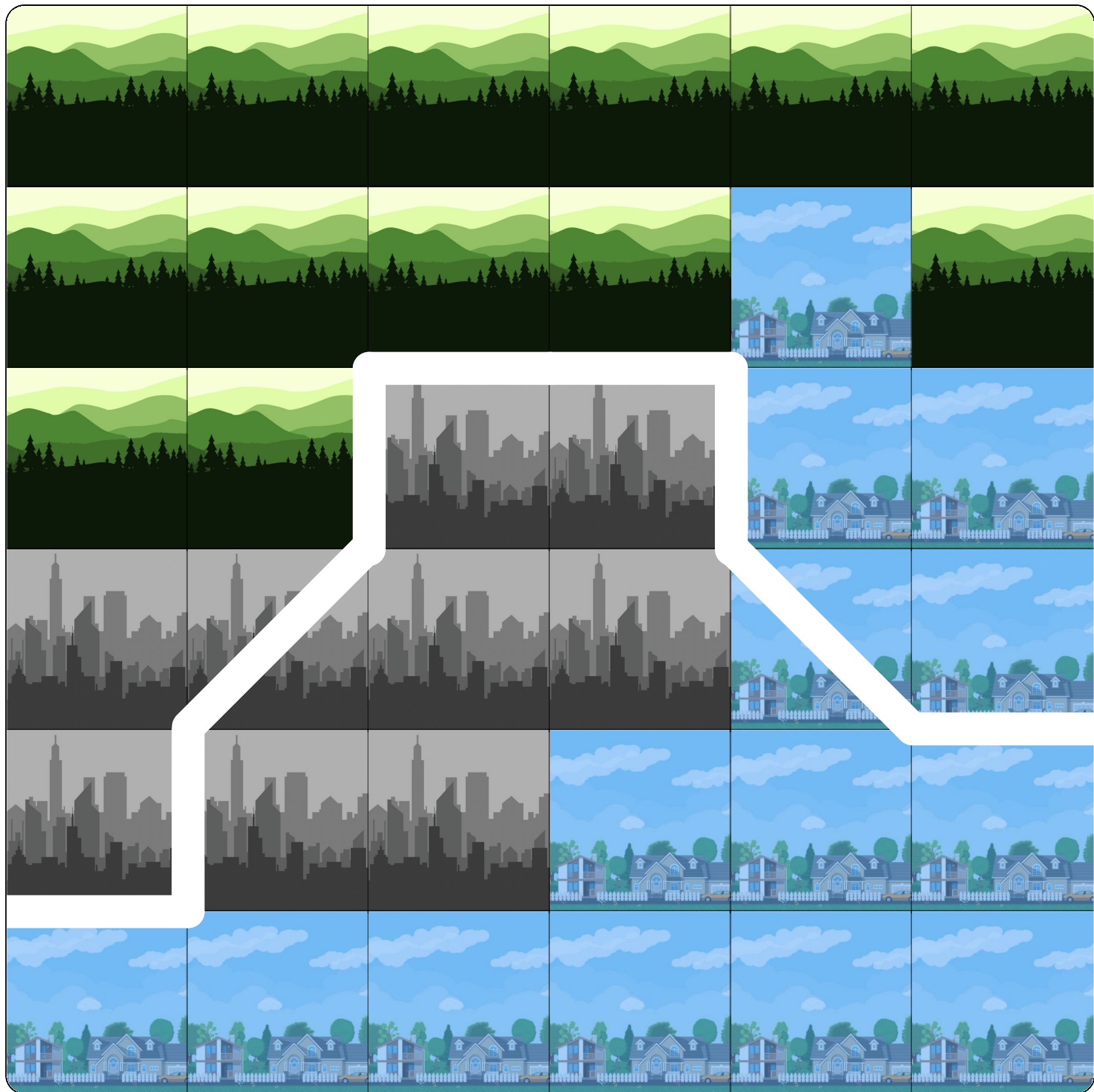

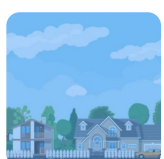
Open Space: Fair Oaks Park

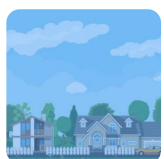
Open Space: Panama Park

When A 'Housing Crisis Worsens' card is drawn...

1. The player immediately reveals the card to the table and draws a new one to replace it.
2. Increase the level of the Housing Crisis by one (it starts at one).
3. Each player adds one permitting token to each affordable project in front of them, building them as required.
4. If the Housing Crisis is level 6 or higher, each player adds **two permitting tokens instead**.
5. Each player removes the number of 'Concern' tokens shown on the housing crisis tracker (if any) from the neighborhood of the player to their right.

When the tenth 'Housing Crisis Worsens' card is drawn, the game ends immediately.

Un-fun fact: As of 2023, there are 9,900 homeless people in Santa Clara County. 75% of them lack shelter.
